IT IS ORDERED that the Mohave County Court Automation User Group is formalized as follows:

1. PURPOSE:

The Committee shall ensure the development of uniform software tables and standardized court user codes, establish additional software codes and/or eliminate or revise existing codes based upon court use of the Progressive Solutions, Incorporated (PSI) FACTS application, and resolve user software issues as needed.

2. MEMBERSHIP:

The membership of the Committee is attached as an Appendix. The Chair of the Committee may suggest the appointment of additional members as necessary.

3. MEETINGS:

Meetings shall be scheduled at the discretion of the Committee Chair.
